PROTECTIVE MEASURES AND CODE OF PRACTICE



Wear protective gloves/protective clothing/eye protection/face protection. Avoid breathing dust/fume/gas/mist/vapours/spray. When using do not eat, drink or smoke. Wash hands thoroughly after handling. Take precautionary measures against static discharge. Use local and general ventilation. Avoid release to the environment. Do not empty into drains.



CONDUCT IN THE CASE OF DANGER

IN CASE OF SPILLAGE

In case of insufficient ventilation, wear suitable respiratory equipment. Wipe up with absorbent material (e.g. cloth, fleece). Wear protective gloves/protective clothing. Use protective eyewear to guard against splash of liquids. Keep away from drains, surface and ground water.



IN CASE OF FIRE

In case of fire, use water or powder extinguisher. Wear self-contained breathing apparatus. Do not allow firefighting water to enter drains or water courses.

FIRST AID



IF ON SKIN: Wash with plenty of soap and water. If skin irritation or rash occurs: Get medical advice/attention



IF ON CLOTHING: Rinse immediately contaminated clothing and skin with plenty of water before removing clothes

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

IF SWALLOWED: Rinse mouth with water (only if the person is conscious). Let water be drunken in little sips (dilution effect). Get medical advice/attention if you feel unwell.

IF INHALED: Remove person to fresh air and keep at rest in a position comfortable for breathing. In all cases of doubt, or when symptoms persist, seek medical advice.

APPROPRIATE WASTE DISPOSAL

Do not empty into drains; dispose of this material and its container at hazardous or special waste collection point. Supply packagings to the national return, collection and recovery systems. Use appropriate container to avoid environmental contamination.
